### Mr Adam Barlow

Consults only at the Spire Leeds Hospital - Thursday afternoon / evening, alternate weeks.

Will see new patients face to face for consultation and review without prior arrangement.

### Mr Tim Broadhead

Consults at the Spire Leeds Hospital – Tuesday evenings and Thursday afternoons, weekly.

Also at the Leeds Nuffield Hospital – Tuesday mornings and Wednesday evenings, weekly.

Mr Broadhead will conduct the first consultation via Telephone or Zoom link only. Patients will be assessed, and any tests or imaging arranged following the initial telephone consultation. Once results are available or Mr Broadhead feels a patient should be seen for examination, a face to face consultation will be arranged.
